<p><b>4) The Lawfulness Conditions and Special Categories</b></p>	<p>The lawful basis for processing, storing and sharing this data are;-</p> <p>Article 6(1)(c) “the processing is necessary for compliance with any legal obligation to which the controller is subject”</p> <p>And in addition an Article 9 Condition for processing should be adhered to;-</p> <p>Article 9(2)(b) – ‘processing is necessary for the purposes of carrying out the obligations and exercising specific rights of the controller or of the data subject in the field of employment”</p>
<p><b>5) Recipient or categories of recipients</b> of the shared data</p>	<p>The data will be shared with organisations including NEL Human Resources, HM Revenue &amp; Customs and future employers where a reference is requested.</p>

<b>6) Rights to object</b>	<p>You have the right under Article 21 of the GDPR to object to your personal information being processed.
