This may include your name, address, date of birth and medical condition and other data we may hold. The data this Clinical Commissioning Group will need to process will depend on the type of litigation or claim received.

This NHS Litigation Authority operates a scheme which this Clinical Commissioning Group pays an annual contribution for, and in return the NHS Litigation Authority supports the settlement of any clinical negligence claims the CCG receives.

<b>4) The Lawfulness Conditions and Special Categories</b>	The lawful justifications for the processing and possible sharing of this data are;-  Article 6(1)(c) “the processing is necessary for compliance with any legal obligation to which the controller is subject”  Article 9(f) “the processing is necessary for the establishment, exercise or defence of legal claims or whenever courts are acting in their judicial capacity”
